### TERMS AND CONDITIONS


1. This Permit is issued for the permittee to operate at the permittee's establishment identified on the previous page of the Permit.
2. This Permit is subject to revocation if found violating Ambient and Source Emission Standards and other provisions of the Clean Air Act and its Implementing Rules and Regulations.
3. During the period of validity, this Bureau may modify this Permit by amending any existing conditions or imposing any new or additional conditions, subject to provisions of Rule XIX of the Implementing Rules and Regulations (IRRs) of Republic Act No. 8749.
4. The permittee shall conduct the actual ambient testing annually in compliance with RA 8749. Thereafter, the submission of Ambient Test Report shall be every June from CY 2023 to 2027.
5. The permittee shall at all times allow any authorized DENR-EMB personnel with proper identification card and travel order shall be allowed unconditional access to conduct an on-the-spot inspection and monitoring to oversee its compliance to the permits and other applicable environmental laws without the need of prior notice to the proponent.
6. The permittee shall at all times have an appointed or designated Pollution Control Officer (PCO) pursuant to DAO 2014-02. The proponent shall submit a valid PCO accreditation upon renewal of this permit.
7. This operating Permit shall be posted in a conspicuous location near the equipment and shall be adequately framed or otherwise protected against damage.
8. Application for renewal of this Permit shall be filed not less than thirty (30) days before the expiration date..
9. The permittee shall submit Self-Monitoring Reports to the Bureau in accordance with DENR Administrative Order No. 27 (Series of 2003). The Self Monitoring Report (SMR) on the operation and maintenance of the aforesaid installations shall be made quarterly and submitted based on the following schedule:
