WASTEWATER DISCHARGE PERMIT

Pursuant to Section 14, Article 2, of the RA 9275 otherwise known as the "Philippine Clean Water Act of 2004", this permit is hereby granted to **Green Horizon Environmental Management Inc.** with office address at Lot 3 Block 6 Golden Gate Business Park I Barangay Buenavista II, Buenavista II, General Trias, Cavite for its establishment:

1. That the permit holder shall discharge Industrial/Domestic Effluent into Pulonan River (Class C waters).
2. The discharge rate of the effluent shall not exceed the 10 cubic meters/ day and that it shall comply with the following standards:

3. That the permit holder shall conduct quarterly effluent monitoring with the above parameters, and shall be included in the quarterly submission of Self Monitoring Report (SMR), based on the following schedule:

4. Submit Certificate of PCO Accreditation within sixty (60) days.
5. That the permit holder shall provide flow measuring device at influent and effluent sides of Wastewater Treatment Facility (WTF). Furthermore, provide an accessible sampling port at the effluent side of your Wastewater Treatment Facility (WTF).
6. That the permit holder shall allow entry to the said facility/establishment and provide immediate, safe and adequate access to authorized representative/s of the DENR-EMB for the purpose of environmental inspection and water sampling.

- 7. This permit, together with the corresponding Official Receipts of Payment, shall be adequately framed and posted in a conspicuous place at the plant/establishment.
- 8. Submit Certificate of desludging of the WTF and treatment of the same by an accredited service provider.
- 9. This Permit shall be renewed thirty (30) days prior to its expiration.

This permit is valid up to Jun 16, 2023, unless revoked or suspended by this Office in writing.

Non-compliance with the above conditions and/or any pertinent provisions of RA 9275 otherwise known as "Philippine Clean Water Act of 2004", a corresponding penalty in the amount of P10,000-P200,000 per violation shall be imposed.
